ORDER

THIS HEARING was held in Toronto, Ontario.

ON READING the Notice of Hearing, the Statement of Agreed Facts and the Joint Submission as to Penalty and Costs, and on hearing the submissions of counsel for the College of Denturists of Ontario ("College") and the Member, Mr. Morgan.

A. THE DISCIPLINE COMMITTEE FINDS that Mr. Morgan is guilty of professional misconduct pursuant to paragraph 2 (failing to maintain the standards of the profession); paragraph 26 (charging a fee that was excessive and unreasonable in relation to the services performed); and paragraph 47 (engaging in conduct and permitting an act, in the course of practicing denturism

that, having regard to all the circumstances, would reasonably be regarded by members as unprofessional), of section 1 of Ontario Regulation 854/93 under the *Denturism Act, 1991*, S.O. 1991, c.25.

B. THE DISCIPLINE COMMITTEE ORDERS THE FOLLOWING PENALTY:

1. Mr. Morgan is required to appear before a panel of the Discipline Committee to be reprimanded on the date of the order.
2. The Discipline Committee shall direct the Registrar to suspend Mr. Morgan's certificate of registration for a period of eight (8) weeks, to commence on a date acceptable to the Registrar.
3. The Registrar will suspend five (5) weeks of the suspension ordered in paragraph 2 if Mr. Morgan successfully, in the opinion of the Registrar, completes all the requirements set out in paragraph 4 of this order within four (4) months of the date of this order. In any event, Mr. Morgan must complete the requirements set out in paragraph 4 of this order within twelve (12) months of the date of this order.
4. The Discipline Committee shall direct the Registrar to impose the following terms, conditions or limitations on Mr. Morgan's certificate of registration:
 - a. Mr. Morgan must submit proof of registration in a course of ethics, approved by the Registrar, to the Registrar;
 - b. Mr. Morgan must, at his own expense, successfully complete to the Registrar's satisfaction, a course in ethics, as approved by the Registrar; and
 - c. Mr. Morgan must provide proof acceptable to the Registrar that he has completed the course in ethics and submit a summary of the learning outcomes of the ethics course.
5. Mr. Morgan is required to pay to the College costs in the amount of \$2,000.00, payable in full no later than sixty (60) days from the date of Mr. Morgan's suspension.
