#### **ORDER**

THIS HEARING was held in Toronto, Ontario.

ON READING the Notice of Hearing and on considering the evidence and hearing the submissions of counsel for the College of Denturists of Ontario ("College") and counsel for the Member.

**A. THE DISCIPLINE COMMITTEE FINDS** that Ms. Tran has committed professional misconduct pursuant to paragraph 7 (failed to fulfill the terms of an agreement with a patient); and paragraph 47 (engaged in conduct or performed an act, in the course of practicing denturism that, having

regard to all the circumstances, would reasonably be regarded by members as unprofessional) of

section 1 of Ontario Regulation 854/93 under the Denturism Act, 1991, S.O. 1991, c.25.

B. THE DISCIPLINE COMMITTEE ORDERS THE FOLLOWING:

1. Requiring Ms. Tran to appear before the panel to be reprimanded immediately following

the hearing.

2. Directing the Registrar to suspend Ms. Tran's certificate of registration for a period of two

(2) weeks, to commence on a date selected by the Registrar.

3. Directing the Registrar to impose a term, condition and limitation on Ms. Tran's certificate

of registration requiring that Ms. Tran successfully complete, by December 31, 2017, to

the satisfaction of the Registrar and at her own expense, the ProBE course in ethics.

4. Requiring Ms. Tran to pay the College's costs fixed in the amount of \$7,500. The costs

will be payable over an eighteen month period in the following intervals: \$2,500.00 on or

before September 1, 2017; \$2,500.00 on or before May 1, 2018; and, the remaining

amount shall be paid in full, on or before February 1, 2019.
