ORDER

THIS HEARING was held in Toronto, Ontario on Monday, October 5th, Tuesday, October 6th, and Wednesday, October 7th, 2015.

ON READING the Notices of Hearing, on hearing the evidence of the witnesses, on reviewing the evidentiary exhibits, and hearing the submissions of counsel for the College of Denturists of Ontario ("College") and the Member, Mr. Irodenko:

A. THE DISCIPLINE COMMITTEE FINDS that with respect to the IL matter, Mr. Irodenko is guilty

of professional misconduct pursuant to section 1 of Ontario Regulation 854/93 under the *Denturism Act, 1991*, S.O. 1991, c.25, paragraph 33 (contravening by act or omission the Act, the *Regulated Health Professions Act, 1991* or the regulations under either of those acts); and paragraph 47 (engaging in conduct and permitting an act, in the course of practicing denturism that, having regard to all the circumstances, would reasonably be regarded by members as unprofessional), and subsection 2(1) of Ontario Regulation 854/93 under the *Denturism Act, 1991*, S.O. 1991, c.25 (using a name or title other than his name as set out in the register in the course of providing or offering to provide denturist services).

B. THE DISCIPLINE COMMITTEE FINDS that with respect to the VC matter, Mr. Irodenko is guilty of professional misconduct pursuant to section 1 of Ontario Regulation 854/93 under the *Denturism Act, 1991*, S.O. 1991, c.25, paragraph 2 (failing to maintain the standards of the profession); paragraph 6 (discontinuing denturist services without adequate reason); paragraph 7 (failing to fulfill the terms of an agreement with a patient); paragraph 10 (making a misrepresentation to a patient including a misrepresentation respecting a remedy, treatment, device or procedure); and paragraph 47 (engaging in conduct and permitting an act, in the course of practicing denturism that, having regard to all the circumstances, would reasonably be regarded by members as unethical and unprofessional),

C. AS A RESULT, THE DISCIPLINE COMMITTEE ORDERS THE FOLLOWING SANCTION WITH RESPECT TO THE IL AND THE VC MATTERS:

1. Mr. Irodenko is required to appear before a panel of the Discipline Committee to be reprimanded on or before January 7, 2016.
2. If and when Mr. Irodenko becomes a member of the College, the Registrar is directed to suspend Mr. Irodenko's certificate of registration for a period of one month, to commence on a date to be set by the Registrar.

3. If and when Mr. Irodenko becomes a member of the College, the Registrar is directed to impose the following terms, conditions or limitations on Mr. Irodenko's certificate of registration:
- a. Mr. Irodenko must submit proof of registration in a course of ethics, approved by the Registrar, within thirty (30) days of becoming a member of the College, to the Registrar;
 - b. Within six (6) months after the date of becoming a member of the College, Mr. Irodenko must, at his own expense, successfully complete to the Registrar's satisfaction, a course in ethics, as approved by the Registrar; and
 - c. Within thirty (30) days of completing the course, Mr. Irodenko must provide proof acceptable to the Registrar that he has completed the course in ethics and submit a summary of the learning outcomes of the ethics course.
4. Mr. Irodenko is required to pay to the College costs in the amount of \$5,000.00, payable in full no later than April 7, 2016.
