NOTICE OF HEARING

THE REGISTRAR OF THE COLLEGE OF DENTURISTS OF ONTARIO (the "College") has referred the reinstatement application of Yasong Chen to the Discipline Committee of the College. The reinstatement application was referred in accordance with section 73(1)(a) of the *Health Professions Procedural Code* (the "Code"). The reinstatement application is attached to this Notice of Hearing as Schedule "A". A discipline panel will hold a hearing under the authority of sections 72 to 74 (including the relevant provisions of the Code referred to therein) of the *Code* for the purposes of deciding whether to reinstate Mr. Chen.

The hearing will be held before a panel of the Discipline Committee (the "Panel") on **October 11, 2018 at 10.00 am at Victory Verbatim, 222 Bay Street, Suite 900, Toronto, M5K 1H6**. You may have a representative appear on your behalf.

SUBSECTION 73(5) OF THE CODE PROVIDES THAT a Panel may, after a hearing, make an order doing any one or more of the following:

1. Direct the Registrar to issue a certificate of registration to the applicant.
2. Direct the Registrar to remove the suspension of the applicant's certificate of registration.
3. Direct the Registrar to impose specified terms, conditions and limitations on the applicant's certificate of registration.

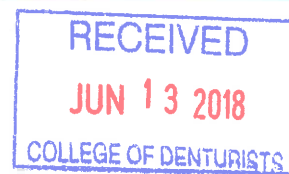

Dear Dr. Pettifer,

Re: Reinstatement – Denturist Certificate of Registration – Yasong Chen

This letter shall serve as a formal application of reinstatement of my Denturist Certificate of Registration (hereinafter referred as the “Certificate of Registration” or “Certificate”) to you honorable College of Denturists of Ontario (hereinafter referred as CDO).

Back to April 28, 2017, a final decision (hereinafter referred as the “Order”) of a revocation of Certificate of Registration was made by the CDO. As a result of my certificate being revoked, I could not use the title denturist and could not perform the controlled act of fitting and dispensing removable dentures. Meanwhile I could not hold myself out as a member of CDO.

It was a Self-Awoke-Up process for me to think about what happened and what will be going on in my future career and daily life. I felt regret for the mistake I made and I fully understand that it was serious enough to lead the certificate being revoked.

It was also a Self-Discipline process. Since the date of my certificate being revoked, I strictly followed the terms and conditions you required in the Order. I have changed my title including in all banks who hold my business accounts, business cards, newspapers. I did not provide any treatment to any patient at any material time in the last one year, even though being a denturist was my only one career for more than eight years and also it was the only one source of family income.

Furthermore, it was also a Self-Improvement process. Denturist is a quickly developed profession involved many new technologies and technical change and improvement. In order to keep myself updated, I took some continuing education courses. In addition, I have read many of the remedial and rehabilitative and disciplining materials on CDO and RCDSO website. From there I understand more about the code of conduct for denturists. This event has become the whole life lesson for me in my career development and professional practice. It secures me to follow the professional code of conduct and law and regulation, when I get a new Certificate of Registration and provide services to the public in a legal way and professional way therefore the public would be adequately protected.

As I mentioned in the previous paragraphs, I had been working as a Denturist for more than eight years since 2009. During the years, I have established a great database of patients with loyalty. During the revocation of Certificate of Registration, many of my patients ever contacted me and requested me to provided services to them. I clearly advised them the effect of my certificate revocation that I could not provide any service before I get certificate reinstated. Certainly, I appreciate very much when the patients expressed that they would like to wait for me until I get my certificate back. For the patients I love, I would like to apply for certificate re-instatement.

Meanwhile, as I mentioned in the previous paragraphs, had been working as a denturist was my only one career since I landed in Canada as an immigrant. I don't have any other skill and expertise in any other field or/and profession. I am the only one bread maker in my family with the children under aged, my wife and senior parents (and parents— in –law) who need my support financially.

Most importantly, I love this career and ever made very much efforts to obtain a certificate of registration through a systematic education and training in the year of 2008. I also devoted very much effort to work as a denturist with accumulated working experience in this field along the time flight by. I have no choice but to submit this application of reinstatement of certificate registration to keep consistency of my career development.

I appreciate very much the Order of CDO dated April 28, 2017 providing me the legal basis and opportunity to apply for reinstatement of certificate registration “no earlier than April 29, 2018”.

By sending this letter, I would formally submit this application to get my certificate reinstated so that I could provide professional services to the patients.

It would be highly appreciated if you could promptly review my application.

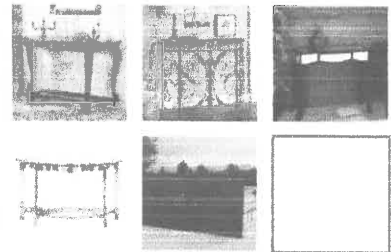
